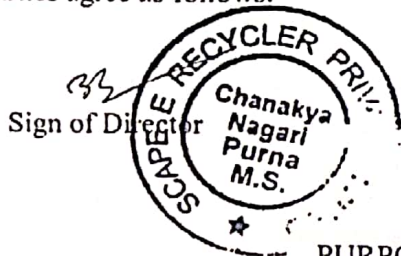
WHEREAS both Parties wish to enable cooperation and exchange in all academic & industrial research areas of mutual interest.

## ARTICLE 2

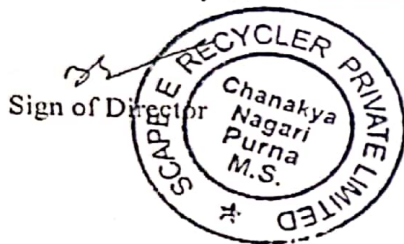
### PROPOSED ACTIVITIES PURSUANT TO THE MOU

- 3.2 Nothing in this MOU shall be construed as granting either Party any rights in or license to use the IP without the other Party's prior written consent, which may or may not be given at that Party's sole and absolute discretion.

## ARTICLE 4

### CONFIDENTIALITY

- 4.2 Confidential information means any and all information in whatever form provided by the disclosing Party and relating to the Activities, provided such information is either (a) marked as confidential at the time of disclosure; or (b) if not in a form that can be readily marked (e.g., an oral, visual or electronic form), is identified by the disclosing Party as confidential at the time of disclosure, or (c) if, given the circumstances of the disclosure, the receiving Party reasonably ought to know that it should be treated as confidential. No disclosure under this MOU or Project Agreement shall be considered an offer to sell or a public disclosure.
- 4.2 The Parties acknowledge and agree that they will maintain the secrecy and confidentiality of confidential information received from the disclosing party under this MOU or Project Agreements. Receiving Party will not disclose the Confidential Information of the disclosing Party to any third party without prior written authorization from the disclosing Party, except that Receiving Party may share the Confidential Information on a need-to-know basis with (a) Receiving party's Affiliates, or (b) to the extent they are subject to a non-disclosure obligation, receiving Party's contractors, agents, students, employees, or representative performing the Activities for receiving Party. Receiving Party will only use the disclosing Party's Confidential Information for the Activities stated in this MOU or Project Agreements. Receiving Party will not remove any confidentiality, proprietary, or other similar markings from Confidential Information. Receiving Party also agrees to

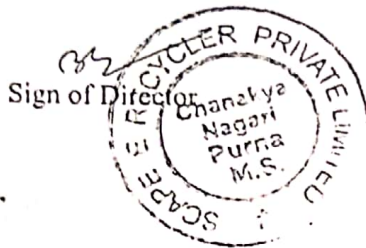


adopt measures to protect the secrecy and confidentiality of Confidential Information that are reasonable under the circumstances and that protect the disclosing Party's Confidential Information with at least the same degree of care, but in any case no less than a reasonable degree of care, as receiving Party uses to protect its own information of a like confidential nature. During the work under this MOU, the Parties will not use or disclose to each other any confidential information owned by a third party, unless the disclosing Party has written authorization to do so.

#### ARTICLE 5

This MOU can be extended by mutual written agreement of both Parties. The termination of this MOU shall not affect the implementation of the projects established under it prior to such termination
