



1) Background : This agreement is entered into by and between Udaygiri Multispecialty Hospital, Udgir Dist. Latur and Swami Vivekanand College of Nursing, Udgir Dist. Latur.

The trustees of Swami Vivekanand Shikshan Prasarak Mandal have establishing an approved professional program as Swami Vivekanand College of Nursing, Udgir. The program curriculum requires special clinical training in preparation for B. Sc. Nursing Programme.

2. The specific nature of this program is to train all the students in nursing while utilizing at Udaygiri Multispecialty Hospital, Udgir over a period of five successive years.

 4. Udaygiri Multispecialty Hospital, Udgir will benefit from making clinical facilities available to nursing trainees of Swami Vivekanand College of Nursing. The Udaygiri Multispecialty Hospital, Udgir will use the trainees' clinical experiences while contributing to the educational preparation of future Registered Nurses.
- II). Understanding : The parties acknowledge and agree to the following:
5. While training at Udaygiri Multispecialty Hospital, Udgir the Swami Vivekanand College of Nursing, Udgir trainees will be under the supervision of facility officials for training purposes and will be subject to and abide by, all Udaygiri Multispecialty Hospital, Udgir rules and applicable regulations.
 7. This program will not result in, nor is it meant to displace employees or impair contracts for services.
 8. The number and assignment of trainees between the Udaygiri Multispecialty Hospital, Udgir will be mutually agreed upon between Swami Vivekanand College of Nursing, Udgir and Udaygiri Multispecialty Hospital, Udgir before beginning of each training period.
 9. In addition to other provisions in this agreement, Udaygiri Multispecialty Hospital, Udgir specifically agrees to:
 - Make available the clinical and related facilities needed for training in the time .
 - Arrange schedules that will not conflict with other education programs.
 - Designate an official to coordinate the trainees' clinical learning experience
 - Provide emergency medical treatment to trainees while at the Udaygiri Multispecialty Hospital, Udgir for trainee.
 - Trainees and faculty shall abide by the Udaygiri Multispecialty Hospital, Udgir's policies. It is understood that trainees and faculty are considered providers or members of the Udaygiri Multispecialty Hospital, Udgir workforce while performing duties.
 10. In addition, to other provisions of this agreement Swami Vivekanand College of Nursing, Udgir specifically agrees to:
 - Provide the Udaygiri Multispecialty Hospital, Udgir a proposed listing of the number of trainees to be assigned, the dates and hours they will be assigned, before the beginning of training period.
 - Provide faculty or staff members who will be responsible for instruction and supervision of the trainees' clinical learning experience.

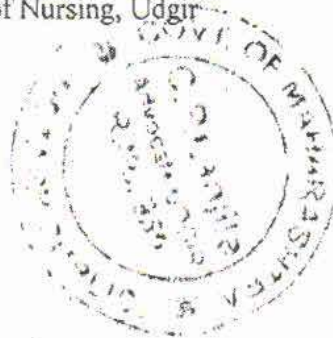
- Have the faculty or staff member who coordinate with the designated Udaygiri Multispecialty Hospital, Udgir official for necessary arrangements

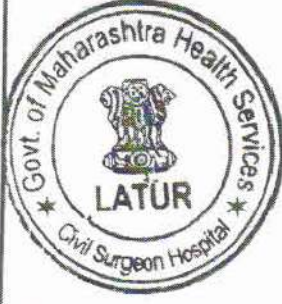
